You are hereby ordered to withhold from the wages of the said Defendant for each pay period the lesser of:

- > Twenty (20) percent of the said Defendant's wages after deduction of all state and federal taxes; **or**
- > The amount of the said Defendant's wages, after deductions of all state and federal taxes, that for each week exceeds fifty (50) times the federal minimum hourly wage. (If the said Defendant's weekly wages, after deducting state and federal taxes, do not exceed fifty (50) times the federal minimum hourly wage, then no amount shall be withheld.)

Withholding shall continue until one year from the date of issuance of this Suggestee Execution, unless the above judgment, interest and costs are sooner satisfied or this Suggestee Execution is sooner released.

**REMITTANCE BY PRIVATE EMPLOYERS:**

During the course of this Suggestee Execution, once every ninety (90) days the amount withheld should be paid to the Plaintiff(s) or to the United States Marshals Service for delivery to the Plaintiff(s).

**REMITTANCE BY PUBLIC EMPLOYERS:**

During the course of this Suggestee Execution, once every ninety (90) days the amount withheld should be paid to the Clerk of Courts or to the United States Marshals Service for delivery to the Plaintiff(s).
